GENERAL

The VAT treatment of e-commerce transactions will change hugely on July 1st 2021.

As of this date, the following changes will occur:

- The former distance sales scheme is no longer applicable.
- The former One-Stop-Shop available for electronically supplied services will be extended to intra-Community distance sales of goods (OSS)
- A new regime for goods imported from third countries will apply (IOSS). This regime has its own One-Stop-Shop.
- Under certain requirements, digital platforms facilitating distance sales will be liable for the collection and payment of the VAT due.
- All the above topics will be examined during the webinar.
